Governing the Degree of Doctor of Philosophy (Ph. D), by Kuvempu University (1st Amendment) Regulations, 2017.

Preamble: There have been many queries and demands from students, academicians, student bodies, public representatives, and the general public to provide eligibility to students who have obtained professional degrees like BE/ B. Tech/ MBBS to apply for Ph. D Programme. Such provisions are very much in place in institutes of national importance like IIT, IISc., where students with 04 year or more undergraduate professional degree are eligible to take up Ph.D course provided they meet all the other conditions laid down by the institution.

Need for the proposed amendment:

i. New Education Policy 2020, being implemented by Government of Karnataka, provide opportunity for the students with a 4 year undergraduate degree (with research), to pursue PhD.

Article 11.10 of NEP states:

11.10. HEIs will have the flexibility to offer different designs of Master's programmes: (a) there may be a 2-year programme with the second year devoted entirely to research for those who have completed the 3-year Bachelor's programme; (b) for students completing a 4year Bachelor's programme with Research, there could be a 1-year Master's programme; and (c) there may be an integrated 5-year Bachelor's/Master's programme. Undertaking a Ph.D. shall require either a Master's degree or a 4-year Bachelor's degree with Research. The M.Phil. programme shall be discontinued.

ii. Premier institutions of the country like Indian Institute of Science (IISc.) and Indian Institute of Technology (IITs) and private varsities like Manipal Academy of Higher Education (MAHE) allow candidates with four or five years undergraduate (UG) degree to pursue PhD in their respective institutions. For example, in IIT, Bombay, BE or B. Tech, which is a 4 years undergraduate course, is considered as one of the minimum qualifying degree for admission to full time PhD programmes.

In view of these existing practices, candidates who have obtained 4 year undergraduate degree with research, including professional degrees like BE/ B. Tech or MBBS, which is a 5 year undergraduate course, from recognized universities, institutes of national importance like IIT, IISc., etc., duly recognized by professional bodies/UGC/MHRD, subject to approval of doctoral committee of the respective subjects, may be allowed to pursue PhD Programme in Kuvempu University.

Presently existing eligibility criteria in the regulation:

04. Eligibility to apply for Admission to Ph. D Programme

4.1. Only the candidates who have obtained a Post-Graduate Degree from a recognized university including foreign students securing not less than 55% marks at the Post-Graduate Degree are eligible to apply for Ph. D Degree Programme.

Candidates who have cleared the M.Phil. course work with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) and successfully completed the M.Phil. Degree shall be eligible to proceed to do research work leading to the Ph. D. Degree in the same Institution in an integrated programme.

4.3. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/differently abled categories of candidates as per the order of the UGC from time to time.

The regulation clearly state that only candidates who have obtained post-graduate degreeare eligible to apply for Ph. D Programme.

Proposed Amendment as an addition to existing guidelines:

"4.4. Notwithstanding the provisions of 4.1 to 4.3, candidates who have obtained 4 year undergraduate degree with research, including professional degrees like BE/ B. Tech or MBBS, which is a 5 year undergraduate course, from recognized universities, institutes of national importance like IIT, IISc., etc., duly recognized by professional bodies/UGC/MHRD, subject to approval of doctoral committee of the respective subjects, are eligible to apply."

The above amendment has been approved in the syndicate meeting held on 27-10-2021. The extract of the proceedings is given below:
