

Proceedings of the Bid Evaluation Committee Meeting for the purchase of Computer, Laptop Hardware and Peripherals through Annual Rate Contract on 16-09-2022 and 20-09-2022.

The University was intended to purchase accessories and spares for continuous and proper maintenance of Desktop and Laptop computers through rate contract by e-procurement mode. For this the university was invited tender repeatedly four times for quoting the bid from eligible bidders vide bid indent Nos. KVVU/2021-22/IND171 dt.07/10/2021, KVVU/2021-22/IND171/CALL-2 dt. 28/12/2021, KVVU/2021-22/IND171/CALL-3 dt.10/01/2022 and KVVU/2021-22/IND171/CALL-4 dt. 05/02/2022. But not succeeded to find the eligible bidder under KTTTP-1991 due to lack of participation, lack of eligibility among the participated bidders, high-priced etc. Finally, based on the recommendation of the committee, re-called the tender for short term period vide tender notification No.KU:UCCF&IT/ARC/28/2022-23, Dated: 20-06-2022 and bid indent no. KVVU/2022-23/IND182.

In response to this 5th call re-notification the only one bidder M/s PACE Computers, Bhadravathi has participated in the bid. The committee discussed about the provision for considering the participated single bidder for technical bid evaluation under KTTTP 1999 Act. Due to 5th call and the provisions in the KTTTP Act(ಅಂಕ 576 ವೆಚ್ಚ-12-2018, ಡಿ.22-05-2018) the committee decided to accept the single bidder for technical bid evaluation.

The committee thoroughly reviewed the bid documents furnished by the bidder and found that the bidder was successfully fulfilled all the conditions as prescribed in the bid. Hence, the committee decided to accept same for the financial bid.

In financial bid, the bidder has quoted the unit prices including all taxes as in **Annexure-I** (Grand Total Rs. 3,44,724/-). The committee thoroughly reviewed the prices quoted by the bidder and found that the quoted price of some of the items are comparatively higher than the market price. Therefore, the committee decided to finalise the prices through negotiation.

Again the committee assembled on 20-09-2022 for finalising the prices through negotiation with the bidder. During the negotiation and after detailed discussion over the quoted prices, the bidder initially bring to the notice of the committee about the typing mistake while typing the prices to three items at e-portal (i.e., Rs. 25000 ->250.00, Rs. 45,000->450.00 & Rs.65000->650.00) and rectified accordingly. Further the bidder was agreed to reduce the prices for some of the items (i.e., sl.nos.06, 08,10,11,20,24,25,26, 30,31, 34, 43, & 46) as in **Annexure-II** (Grand Total of Rs. 1,46,814/-). Finally, the committee agreed to accept the negotiated revised prices over quoted prices of M/s Pace Computers and Hardwares for supplying Computer, Laptop Hardware and Peripherals through annual rate contract for the period of two years from the date of the agreement and with the approval of the Hon'ble Vice-Chancellor.

Finally, the convener extended the thanks to the Chairman and all the members of the committee for making the success of the meetings with their suggestions and support.
