CONDITIONS

01. The tender forms can be obtained from The Executive Engineer, Kuvempu University, Shankaraghatta after paying the cost of the tender form and EMD amount in the form of D.D only favoring The Finance Officer, Kuvempu University, Shankaraghatta, payable at State Bank of Mysore, B.R. Project and Producing the copy of Registration and Banker's Cheque can not be accepted
02. Last date for submission of application for issuing blank tender is 03-09-2009
03. Blank tender forms shall be issued on 05-09-2009
04. Last date for receiving completed sealed tenders is upto 11-00 AM on 09-09-2009 at the Office of the Executive Engineer, Kuvempu University.
05. The tenders will be opened on 09-09-2009 at 11.30 AM or the next date as fixed by the Registrar.

06. The Contractors who have not participated in tender process before, by taking tender booklets two or three times, in Kuvempu University are not eligible to participate in this tender.
07. Conditional tenders are liable for rejection.
08. The University reserves the right to reject the tenders without assigning any reasons whatsoever and no enquiry in this regard would be entertained.
09. The Tenderer shall get electrical and water supply connection at his own cost.
10. The Tenderer should have the Latest V.A.T. Clearance Certificate and I.T Clearance Certificate and should enclose them to the Technical Bid.
11. Tender form shall be submitted along with the details of machinery like mechanical excavators, tippers, concert mixers, vibrators and other any machinery required to be deployed for successful completion of the work. In case any of these machinery are proposed to be hired, sources of such machinery with necessary consent letter from the owner of these machinery shall be obtained and furnished
12. Materials like steel, cement, etc., required for the work shall be procured by the contractors themselves and should be got tested by the quality control authority, before use on the work, at his own cost. University shall not be responsible for variation in rates.
13. Work experience certificate and financial capability particulars with convincing program of completing the work within the stipulated time limit should be produced along with the tender.
14. Necessary work experience certificate issued by the competent authority, not below the rank of Executive Engineer indicating the nature/ items of work executed, date of commencement, date of completion and total cost of work executed etc., shall be furnished in the technical bid, without these details they are liable for rejection.
15. Each tenderer should have satisfactorily completed in his own name at least one work of similar type of not less than the 50% of value of the work, for which tender is called for, during the preceding 2 years in a span of same period as mentioned in the notification.
16. The tenderer should have achieved in his name a minimum annual financial turn over of at least the same value of the work called for in the stipulated period, in the past five years.
17. Penalty will be collected from the contractor for the delay of work or for the shortfall of the progress as per PWG 65 stipulation.
18. All other conditions are as per PWG-65 (KPWD).
