- 4 All the documents uploaded to the KPPP-portal should be self attested by the contractor or an authorized representative in case of firm / company.
- 5 If the successful bidder has quoted lesser rates than the estimated rates, then he should remit the unbalanced tender amount as additional security deposit along with the security deposit.
- 6 If any of the dates mentioned above happened to be a general holiday, the next working day will be considered.
- 7 Conditional tenders will be rejected. The Registrar, Kuvempu University shall have the right to accept the tenders or reject any or all the tenders without assigning any reason.
- 8 18% GST shall be paid to the tendered amount separately.
- 9 As per Karnataka State Government order LD/300/LET/2006 Bangalore dated 01-01-2007 and Government letter No PW/134/BMS/2007 dated 27.07.2007, a sum amounting to 1% of the bill amount will be deducted towards construction labour welfare fund.
- 10 Site visit Letter: The prospective bidder should visit the site collect all the information from the authorized representative of Engineering Division, Kuvempu University and upload the site visit certificate in the e-portal to this respect issued by Asst. Executive Engineer, Kuvempu University.

11. The successful tenderer if need temporary electrical/water supply connections, he may have to apply for the permission of Executive Engineer, Kuvempu University.
12. The successful bidder should get approval from the Electrical Inspectorate in his own cost for the Supply, erection, testing and commissioning of Electrical installation
13. Income tax / GST as per prevailing Karnataka Tax Act and Royalty charges as per Government orders issued from time to time shall be deducted from every running Account bill
14. It is the responsibility of the contractor to obtain the test results of the materials from the third party / Engineering colleges etc., wherever applicable.
15. Corrigendum will be published in the website for modifications / corrections / cancellations, if any.
16. The tenderers have to abide instructions and conditions contained in the Standard Bid Documents - KW-2 and further orders thereof.
