8. Conditional tenders will be rejected. The Registrar, Kuvempu University shall have the right to accept the tenders or reject any or all the tenders without assigning any reason.

9. 12% GST shall be paid to the tendered amount separately.
10. As per Karnataka State Government order LD/300/LET/2006 Bangalore dated 01-01-2007 and Government letter No PW/134/BMS/2007 dated 27.07.2007, a sum amounting to 1% of the bill amount will be deducted towards construction labour welfare fund.
11. The successful tenderer if need temporary electrical/water supply connections, he may have to apply for the permission of Executive Engineer, Kuvempu University.
12. The successful bidder should get approval from the Electrical Inspectorate in his own cost for the Supply, erection, testing and commissioning of Electrical installation
